YOUR DAY BY DAY ITINERARY

DAY 1: PARIS

Upon arrival in Paris, we are met and greeted by our assistant, and next board our deluxe coach to transfer to the river cruise port where we embark on the ship. We are immediately captivated by the beauty of France's capital city as we commence our journey here in the city known as the "City of Lights". After a welcome cocktail we enjoy our dinner on the ship. Join us for a cruise through Paris "by night" (depending on the water level). Overnight on the ship. (D) **Passengers are welcome to board the ship at 6:00 p.m.**

DAY 2: PARIS

This morning, we enjoy a panoramic tour of the city's famous landmarks. We begin with a drive along the Champs-Élysées, passing the iconic Arc de Triomphe, and continue to the grand Place de la Concorde. Admire the elegant Opéra Garnier and the historic Notre-Dame Cathedral, a masterpiece of Gothic architecture on Île de la Cité. Travel past the Louvre Museum, and the Tuileries Gardens. Make a stop near the Eiffel Tower, where we have time to capture photos of this global symbol of Paris and take in the surrounding beauty. We conclude the tour with views of the Grand Palais, Petit Palais, and the regal Les Invalides, home to Napoleon's tomb. In the afternoon we visit the magnificent Palace of Versailles, the opulent residence of French kings and a UNESCO World Heritage Site, and its gardens. After the tour we return to our ship. Overnight on the ship. (B/L/D)

DAY 3: PARIS / LE ROCHE - GUYON

We spend this morning sailing towards Le Roche-Guyon where we board our coach to the charming village of Giverny, where Claude Monet lived and worked from 1830 to 1926. We explore the enchanting flower garden and his home. Feel the enduring spirit of Impressionism in this beautifully preserved sanctuary before returning to the boat in Vernon by late afternoon. Overnight on the ship. (B/L/D)

DAY 4: HONFLEUR

In the afternoon we arrive in Honfleur where we board our coach to discover The Cote Fleurie. Our first stop is Deauville, a glamorous coastal city known for its elegance and iconic 1923 boardwalks. Then, we continue to the stunning Chateau du Breuil in the heart of Pays d'Auge, surrounded by lush greenery. Explore its rich architecture and visit its distillery to learn how Calvados is made, followed by a tasting. Return to the boat in Honfleur by coach. Overnight on the ship. (B/L/D)

DAY 5: HONFLEUR

Today we enjoy a full day guided tour to the Landing Beaches of Normandy. We start at Pointe du Hoc, a key site from the D-Day landings on June 6, 1944. Continue through Omaha Beach, Colleville-sur-Mer, and its American cemetery. After lunch, we head to Arromanches to explore the site of the battle and its famous artificial port. Visit Arromanches 360° to watch The Price of Liberty, a powerful film combining 1944 archival footage with present-day views. We return to Honfleur via Gold, Juno, and Sword Beaches, arriving in the early evening. Overnight on the ship. (B/L/D)

DAY 6: HONFLEUR / ROUEN

We spend our morning cruising towards Rouen. Upon arrival, we begin our guided walking tour of Rouen with a short stroll from the ship to the city's historic center. We visit the magnificent Notre-Dame Cathedral, renowned for its intricate Gothic façade; the Old Market Square, where Joan of Arc was martyred in 1431; the Gros-Horloge, a 14th-century Gothic clock tower symbolizing the city's rich heritage; and the modern Saint Joan of Arc Church, honoring the French heroine. We return to the ship on foot in the late afternoon. Overnight on the ship. (B/L/D)

DAY 7: ROUEN / LES ANDELYS

After morning sailing we arrive to the port in Les Andelys from where we walk to the Château Gaillard. We discover this ruined medieval castle and its gorgeous views overlooking the small city of Les Andelys and one of the loveliest bends in the Seine. After our hike and visit, we'll return to the ship by coach. Tonight, we enjoy our farewell gala dinner. Overnight on the ship. (B/L/D)

(*The Chateau Gaillard is closed on Tuesdays*)

DAY 8: PARIS

After breakfast we transfer to the airport for our flight back home. (B)

TERMS AND CONDITIONS

Tour prices: All prices in this brochure are based on airfares, land rates and exchange rates in effect at the time of printing and on group rates of 30 passengers or more. Tours may depart with less than the required number of passengers, at the discretion of Group IST, LLC (doing business and referred to therein as "Journeys Unlimited"), but an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations, changes in fuel prices and/or unforeseen economic circumstances.

Reservations, Deposits and Final Payments: Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per person deposit plus applicable (optional) insurance. Receipt of your deposit shall act as your agreement to these terms and conditions. Balance is due 75 days before departure date. If final payment is received less than 75 days, a late fee will be assessed in the amount of \$50.00. If final payment is made by credit card (American Express, Visa, MasterCard), Journeys Unlimited requires a completed credit card authorization form. All payments made by check should be made payable to Journeys Unlimited.

Late Reservations: If a booking is made within 60 days of departure, full payment plus applicable taxes and optional insurance is due at the time of booking. There will be a \$50.00 late processing fee applicable plus cost of any express or overnight mail services. No personal checks will be accepted with reservations received 30 days or less before departure date. Money order, bank check, certified check or credit cards (American Express, Visa, and MasterCard) will be accepted.

Travel Documents: A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for US passport holders traveling to some destinations; please contact our office for details. All non-US citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition non US citizens are responsible for complying with requirements for re-entry into the USA. Journeys Unlimited assumes no responsibility for procurement of passport or visas. Obtaining and carrying these documents is the sole responsibility of passengers. Journeys Unlimited will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation.

Final Documents and Tickets: All documents and tickets are only issued upon receipt of final payment and are sent within 3 weeks of departure. Documents and tickets are not guaranteed if final payment and booking form are not received on time.

Air from Home City: All brochure departures are based on a New York area airport. Journeys Unlimited can help arrange air transportation from your home city airport. Journeys Unlimited is not responsible for any penalties incurred on domestic tickets not purchased from us, in case of changes in the schedule of the tour. If you are making your own domestic airline tickets, please make sure that your domestic flight time arrives at least 4 hours prior to your international departure time.

Air Changes, Cancellations & Refunds: Airline tickets issued by Journeys Unlimited are highly restrictive and in most instances cannot be reissued, revaluated or exchanged. If a change is possible, a \$75 per person administrative fee, plus any applicable airline change fees, will be assessed once air tickets have been issued. Airline penalties vary depending on carrier.

Airline Seat Assignments and Special Services: There is no advance seat selection. Early check-in is necessary to secure seats with travel companions. Seating is solely under control of the airlines. Some airfares used may be eligible for frequent flyer mileage.

Baggage: The company is not responsible for any additional charges collected by the carriers at the airport for luggage fees. We recommend that you take along one suitcase per person with a maximum weight of 50lbs., plus one carry on with maximum dimensions of 9"X14"X22". Airlines also have their own baggage restrictions; please check with the air carrier prior to your departure. All baggage is the passenger's responsibility throughout the tour. Journeys Unlimited is not responsible for loss, theft or damage to your baggage. If a bag is lost or damaged in-flight, the passenger is responsible for notifying the airline directly.

Airline Clause: The airlines concerned will not be held responsible for any act, omission, or event during the time passengers are not aboard their aircraft. The passenger tickets in use by the airline, when issued, shall constitute the sole contract between airline and the purchaser of these tickets and/or passenger. These tours may be sold in connection with the services of any ATC or IATA Airline.

Rooms: Prices shown in the brochure are per person, based on two persons sharing a hotel room or cabin. A limited number of single rooms are available at the supplement shown per tour. In some cases, when requested, we may be able to find an appropriate roommate for passengers who have booked as a single person. **If a roommate is not available, you must pay the single room supplement.** While single rooms provide privacy they are often smaller than twin bedrooms. Triple rooms are available in many hotels for family or friends traveling together. There are no discounts for triple rooms.

Medical Conditions: While we endeavor to provide the highest level of service to all our passengers, we cannot guarantee special facilities or assistance for disabled passengers and it is your responsibility to arrange for such assistance as required. We regret that we cannot provide individual assistance Journeys Unlimited is not responsible for any medical conditions that may occur prior, during, or after the tour.

Land Only Bookings & Tour Deviations: All Journeys Unlimited packages include airfare from the city designated. Land only bookings will be invoiced based on adjusted price. Arrival and departure transfers are not provided for land only bookings. Any deviations from the tour, requested by the client, will be assessed a charge of \$100.00 per person, plus any additional costs the change may incur.

Responsibility: The tour member understands that he or she has no claim against Journeys Unlimited, and its affiliates, for any delay or damage to or loss of property or baggage or injury to or death of persons due to any neglect or willful act of a direct air carrier, hotel, bus company, steamship or cruise company, railroad, transportation company or service company of any kind, or any other person or persons rendering any of the services being offered in connections with these tours. In calculating the cost of the trip, Journeys Unlimited has relied on your consent to these terms and in the absence of this release, the cost of the trip would be higher. A contract is made when your reservation and payment are accepted by Journeys Unlimited and any dispute shall be governed by New York law. We reserve the right to decline to accept a person, or remove a person from a tour, if such person presents a significant risk to the health or safety of himself or the group and the person cannot otherwise be reasonably accommodated.

Cancellation Policy and Refunds: We hope that nothing will prevent you from taking your Journeys Unlimited pilgrimage. However, should you need to cancel, your cancellation must be received in writing, via email, fax or by letter. It will be effective on the date of receipt. If you cancel your tour after you have received your documents and airline tickets, you must return them to Journeys Unlimited before we can process your refund.
